

RP LAWMAKERS VISIT GREECE, MEET FILCOM LEADERS

Ambassador Rigoberto Tiglao warmly received the officials of the Committee on Appropriations of the House of Representatives led by Deputy Speaker Raul del Mar (Cebu, 1st district), Rep. Junie Cua (Quirino), Rep. Narciso Recio Bravo Jr. (Masbate, 1st district), and Rep. Thelma Almario (Davao Oriental, 2nd district), who visited Greece from 18 to 23 March 2009.

The lawmakers were accompanied by their respective families and technical staff.

Ambassador Tiglao accompanied the visiting lawmakers to the Filipino Workers Resource Center (FWRC) in Ambelokipi.

The lawmakers inspected the facilities at the FWRC and discussed the working conditions of the overseas Filipino workers in Greece, both land-based and sea-based, with the Ambassador and Labor Attaché George Eduvala.

After inspecting the FWRC, the lawmakers met with leaders of the Filipino community at a meeting organized by Ambassador Tiglao at the Philippine Embassy. At the meeting,

OAV Registration to be held every Sunday until 31 August 2009

The Philippine Embassy is pleased to announce that starting last 26 April 2009, and thereafter every Sunday of the month until 31 August 2009, the Philippine Embassy will be holding registration of new overseas absentee voters for the 2010 national elections from 10:00 A.M. to 2:00 P.M.

We urge all our *kababayans* residing in Greece, who are at least eighteen (18) years of age on the day of elections and are not disqualified by law, to register as overseas absentee voters.

Overseas voting period for the 2010 National Elections will be held from 10 April 2010 to 10 May 2010, 3:00 P.M. (Manila time). ■

A Pinoy Butcher in the heart of Omonia

The following article contains excerpts from an article of the same title and author featured in the January 2009 issue of "Buhay OFW," a publication of Atlas Publishing Co. Inc.

Omonia Square is said to be the pride and joy of Athens – and also its oldest square. Omonia played a part of the grandeur that was Greece. Philosophers and famous people used to frequent this place to hang out, talk about their stuff, drink coffee or just simply gaze to while their time away.

At its very center, is the Agora --- the Omonia Market.

Here, you will find Danilo 'Dan' Robles, an overseas Filipino worker and a popular butcher among Greek and Pinoy meat buyers. Gifted with a disarming smile and a pleasant disposition, Dan is easy to get along with, able to talk freely about his feelings, known to wield a sharp knife with the gentlest of smiles. No wonder he is deeply trusted and liked by his Greek employer – Dmitri who took Dan under his employ in 1995.

Dan started as a part-time worker with Dmitri receiving 50 Euros, for a day and a half work on Fridays and Saturdays. Since then his status as a butcher improved and now he earns more than 1,000 Euros per month -- 250 Euros as basic pay per week -- excluding tips that he shares with his co-workers. In addition, Dan receives the usual social security benefits just like any other Greek worker.

A proud native of Davao, he is the 6th

child from a brood of 9, born and educated in the South of the Philippines. He was 16 years old when he left their house to study in another town taking up BS Agriculture majoring in animal husbandry at the state owned University of South Mindanao. Unfortunately, money was hard to come by and he was forced to drop out of school on his third year and got married. Dan survived by doing odd jobs in the province in factories like Coca-cola and Franklin & Baker and at piggeries from the late 70s to the early 80s to support a growing family of three children.

In the years that followed Dan with the help of a relative found a job in Greece. In the intervening years, Dan's personal and family life suffered that led to the breakup of his marriage.

Eventually, Dan found work as a janitor in a language school in the 90's. Determined to earn more money to save for his children, Dan did part time work at the Omonia market as a butcher. Dan eventually left his janitorial job to become a permanent employee of his kind and amiable boss Dimitri.

About this time, Dan also became actively engaged in Filipino community activities and joined the VIZMIN organization, a group of Filipinos from the Vizayas and Mindanao. He also became a member of a support group, The Reevaluation

Counseling Group – composed of a group of professional psychologist with American, Greek and Irish nationalities.

Stability in finances did not guarantee stability in emotions. Seeking solace in his work and in serving the Filipino community, Dan felt the stirrings of a fresh beginning.

And as if obtaining the blessings of the Greek gods, Dan met Emma and the two fell in love. Emma provided the stability Dan was looking for in his life, the emotional support he needed to confront the problems he had faced in his life.

Dan remains active in the community. He reorganized and reestablished the United Visayan Mindanao (UVM) where he is the current president.

Dan and Emma are blessed with a daughter – Paula, now 10 years old. He remains active in the Reevaluation Counseling Group, president of UVM and member of the Active Community Partners (ACP) composed of the different Filipino organizations in Greece. He is also the current president of Filipino Bowlers Association in Greece (FILBAG) and is considered one of the best Filipino bowlers in Athens. Clearly, the butcher that bowls now has his future cut out for him. ■

Validity of Green Passports (Non-Machine Readable Passports)

The Philippine Embassy in Athens wishes to reiterate the advisory issued in February 2009 by the Department of Foreign Affairs announcing that all green passports (non-machine readable passports) will be valid until the stated date of expiry.

However, the Philippine Embassy accepts and processes passport renewal applications filed by those who wish to have their green passports renewed prior to the date of expiry.

The Philippine Embassy in Athens, Greece has been issuing machine readable passports (MRPs) since June 2008. ■

GUIDELINES ON MINOR CHILDREN (BELOW 18 YEARS OLD) TRAVELLING UNACCOMPANIED BY PARENTS

1. The parents of the child, if residing and working in Greece, will execute an Affidavit of Parental Travel Permit and Consent at the Consular Section of the Philippine Embassy.
2. Personal appearance of parents is required.
3. Present valid Philippine passports and submit two sets of photocopies of said passports.
4. **Payment of notarial fee of €25,00 (Twenty Five Euros).**
5. For children travelling from the Philippines to Greece, the relative or authorized representative of the **child's parents must secure a Travel Clearance** for the child from any Field Office of the Department of Social Welfare and Development (DSWD).

Photo Requirements for Machine Readable Passports (MRPs)

1. Size: 4.5 cm x 3.5 cm
2. Royal or dark blue background color
3. Full frontal shot
4. Image of the applicant should occupy approximately 70-80% of the photograph.
5. There should be at least 5mm-10mm space between the crown/head of the applicant and the edge of the photo.
6. *Preferably*, photograph is printed on matte paper.
7. Applicant must be in decent attire, preferably with collar. (For women, no sleeveless blouses or plunging necklines.)
8. Use of contact lens, sunglasses, and eye glasses for medical reasons is allowed.
9. Use of headscarf/veil for religious and/or medical reasons is allowed.

Requirements in Securing a Travel Clearance from DSWD

- Duly-accomplished application form which may either be obtained from any DSWD Field Office or downloaded from www.dswd.gov.ph.
- Photocopy of the birth certificate or passport of the child
- Written consent of both parents or solo parent or legal guardian permitting the child to travel alone or with another person to a foreign country
- As appropriate,
 - Photocopy of the marriage certificate of the child's parents or
 - Photocopy of the certificate of legal guardianship of the child or
 - Photocopy of the solo parent identification card from the municipal social welfare and development office or Tallaq or Fasakh Certification from the Shariah court or any Muslim Barangay or religious leader
 - In case of an illegitimate child, a certificate of no marriage (CENOMAR) from the local civil registrar
 - In case of a deceased parent, a photocopy of the death certificate
- Two (2) colored passport size photos of the child taken within the last six (6) months.

1. Karapatang makipag-ugnay sa isang *Welfare Officer* na magbibigay ng suporta, tulong, at impormasyon kung paano makakakuha ng karagdagang tulong mula sa iba pang ahensya sa Cyprus.
2. Karapatang makakuha ng impormasyon sa wikang ginagamit at naiintindihan. Maaaring kumuha ng serbisyo ng isang tagapagsalin o *interpreter*.
3. Karapatang maprotektahan ang mga impormasyon ukol sa sarili nang naaayon sa mga batas sa Cyprus hinggil sa *Personal Data Processing (Law 138 (I) 2001 at Law 37 (I) 2003)*.
4. Karapatang makatanggap ng sustento mula sa *State Allowances Fund* kung walang kakayahang gumastos sa pang-araw-araw na pamumuhay ayon sa Law 95(I) 2006. Kailangan rin na ang manggagawa ay kasalukuyang naninirahan sa teritoryo ng Cyprus at walang trabaho o pinagkakakitaan.
5. Karapatang mabigyan ng abogado na kakatawan sa korte, kung walang kakayahang pinansyal, ayon sa *welfare provisions* ng batas ukol sa *Legal Assistance (Law 165 (I) 2002)*.
6. Karapatang mabigyan ng tulong *medical at psychological* ng Ministry of Health. Ang *Welfare Officer* ang gagabay sa manggagawa sa pagkuha ng kaukulang tulong pangkalusugan.
7. Karapatang maprotektahan mula sa mga tao o pangyayari na maaaring magdulot ng kapahamakan. Kung sakaling mangyayari ito, marapat na ipagbigay-alam ng manggagawa sa *Welfare Officer* na siyang magpaparating sa kaalaman ng pulisya.
8. Karapatang sumali sa mga programang layunin ay makapagbigay ng kaukulang tulong, tulad ng mga espesyal na kurso na makakapagpabuti ng kakayahan sa iba't ibang larangan at pakikipag-ugnay sa komunidad.
9. Karapatang manirahan sa *State Shelter/ Home*. Ang manggagawa ay bibigyan ng impormasyon ng *Welfare Officer* kung aling *State Shelter/ Home* ang maaaring kumupkop sa kanya. Kung hindi nais ng manggagawa na tumigil sa *State Shelter/ Home*, ang *Welfare officer* ay magmumungkahi ng iba pang solusyon para sa ikabubuting kalagayan ng manggagawa.

36 Filipino seamen released by Somali pirates; 23 repatriated

17 Filipino seamen on board mv Titan and 19 more on mv Saldanha were released by Somali pirates unharmed on 15 April and 25 April 2009, respectively. MV Titan was seized by the pirates on 19 March 2009, mv Saldanha on 22 February. Labor Attache George Eduvala and Labor Officer Tito Baldago of the Philippine Embassy in Athens had been meeting and in constant contact with the Greek agents managing the two ships since their capture. Forty more Filipinos remain

in two hijacked ships managed by Greek companies. Eighteen are on mv Napayia, seized on 25 March, and 22 on mv MV Irene E.M, seized on 13 April. The shipowners confirmed that they are all safe and free from harm. (In August last year, a Filipino crew was killed when the pirates boarded and hijacked a Malaysian oil tanker; in May 2007, a Chinese crew was killed because the shipowner failed to meet the pirates' ransom demand). The POLO staff of the Philippine Embassy is also monitoring their situation, and their families in the Philippines are regularly informed of their well-being.

As of 25 April 2009, there were 56 other Filipinos in vessels, not owned or managed by Greek companies, captured by the Somali pirates: 29 are on fv Win Far and 24 on mv Malaspina Castle, both seized on 6 April; three on d/b Pompei, seized on 18 April, and 15 on mv Patriot, hijacked on 25 April.

The DOLE and DFA in Manila are closely monitoring the situation of the 96 Filipinos who remain off the coast of Somali.

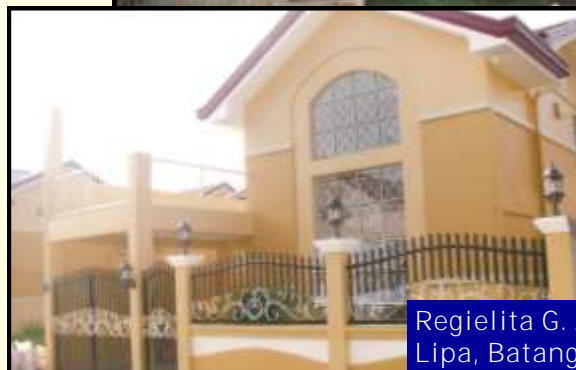
Since the beginning of the year (until April 25), 50 vessels were attacked by Somali pirates and half were captured and held for ransom. Eleven ships (and the 158 crew on board – including 36 Filipinos) had been released or rescued; only fourteen ships (with 154 crew members – 96 of them Filipinos) remain.

Earlier, in February, the POLO attended to the repatriation of 23 Filipino seamen on board four vessels stranded in the other side of Africa. Mt Trader, mt Eva II, mt Torero and mt Meridith were stranded in Nigeria. The POLO made representations with the Greek ship agent, Corinthian Maritime SA for Maritime Management Synergy SA and Golden Carriers Shipping, towards the early repatriation of the crew. ■
